Dear WLBC Students, Alumni, Administration and Staff, Faculty, Denominational Sponsor and Supporters, Family and Friends:

We are writing to report progress in our pursuit of reinstatement to the accredited status. We were given three years to achieve reinstatement, following our February 2014 decision to withdraw. A Team Visit was conducted by the Association for Biblical Higher Education (ABHE), September 2015, followed by two consultant visits (one in November and another in December 2015). As we have conveyed to you in the past, our ability to generate diverse streams of revenue has been most problematic in our performance. Over the past two years sustainability plans have been improved by both the Board and College Interim President-CEO. In addition, provisions were made by the Founding President, the late Dr. William L. Bonner, to preserve the WLBC legacy. With this increase and enhancement in fiscal resources, the College would have been able to complete action steps to other plans associated with hiring (College Dean; College Librarian, and Chief Fiscal Officer), in a timely fashion. With the unforeseen circumstances that occurred, a decision was made to defer going before the Commission of Accreditation (COA) until our final year (February 2017). During this period we will strengthen performance in all core areas, bringing the College to its highest level of institutional stability and effectiveness.

The College evaluates its performance in light of its own stated mission, as well as ABHE Standards for Accreditation. In reviewing overall results of our assessment plans, we realize that an additional year will enable us to achieve some of the additional desired outcomes, and also prompt a more favorable decision by the COA in February 2017.

Please join us in prayer over the next year that the Lord will send faithful friends and supporters, who will assist us in preserving our rich legacy, initiated by our Founding President, Dr. William L.
